### APPLICATIONS

Always test for compatibility with, and the colorfastness of, the surface to be cleaned by applying a small amount of the Spotter to an inconspicuous area. **R2x Green Stain & Soil Remover** can be used on all water-safe fibers and has Carpet & Rug Institute® (CRI) seal of approval. **TOTALCARE® "Green" Carpet STAIN & SOIL Remover** can be used as a spotter, a pre-spray, in truckmounts supply tanks or other types of carpet equipment.

As a pre-spray allow **TOTALCARE® "Green" Carpet STAIN & SOIL Remover** to dwell on the area for 5 to 10 minutes to penetrate into the fibers and loosen the soil. Used as a spotter, spray soiled area, allow dwell time, agitate, and blot with a clean white cloth. Allow the area to dry for 15 to 30 minutes. For stubborn stains, it may be necessary to repeat the cleaning process. If needed, use a carpet tamping brush to agitate the area.
