OVERVIEW

TOTALCARE® Odor Control Carpet Cleaner is a dual purpose product; it controls odors as it deep cleans carpet fibers. It is the perfect cleaner for heavily soiled traffic areas in managed health care facilities, hospitals, day care centers, or other locations where odors may occur. **TOTALCARE® Odor Control Carpet Cleaner** removes even the toughest soils and stains as it eliminates the most severe odors caused by urine and other organic substances, **without the use of enzymes**. With **TOTALCARE® Odor Control Carpet Cleaner** stains will not reappear after cleaning, and the cleaned area will stay clean longer due to the non-soiling nature of the product.

HOW & WHY TOTALCARE® ODOR CONTROL CARPET CLEANER WORKS

Odors are small unpleasant chemical molecules that travel through the air and are detected by the sensitive receptors of the nose. **TOTALCARE® Odor Control Carpet Cleaner** works by making the odiferous molecules too large and heavy to become airborne. To do this **TOTALCARE® Odor Control Carpet Cleaner** uses a specially modified organometallic salt that surrounds and binds to the most common odor-causing chemical molecules, essentially encapsulating the odor. This effectively removes the ability of the molecules to be smelled. While the organic malodors are being neutralized and encapsulated, the specially selected nonionic and anionic surfactants within **TOTALCARE® Odor Control Carpet Cleaner** are deep cleaning carpet fibers to remove stubborn stains and soils. While other cleaners can clean with varying degrees of success, they may leave behind a residue. This residue can act like a dirt magnet and attract soils and dirt, causing re-soiling of the area. **TOTALCARE® Odor Control Carpet Cleaner** is different. As a result carpets remain cleaner longer.

APPLICATIONS

Always test the surface to be cleaned for compatibility, and colorfastness, by applying a small amount of the **TOTALCARE® Odor Control Carpet Cleaner** to an inconspicuous area.

Spotter: Spray soiled area with **TOTALCARE® Odor Control Carpet Cleaner**, agitate, allow dwell time, and blot with a clean white cloth. Allow the area to dry for 15 to 30 minutes. For stubborn stains, it may be necessary to repeat the cleaning process. If needed, use a carpet tamping brush to agitate the area.

Pre-Spray: Pre-spray **TOTALCARE® Odor Control Carpet Cleaner** at 50 sq. ft per quart. Agitation is recommended. Allow to dwell on the area for 5 to 10 minutes to penetrate into the fibers and loosen the soil. (Do not allow product to dry.) Extract using only clean hot water.
